CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSISTANT** initially for a period of **01 Year**, or till the project is over on a temporary contractual basis in the project entitled **“Value-added products using transglycosylating α -glucosidase” (MLP-0303)** at the Department of **Microbiology & Fermentation Technology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: B.Sc./03 Years Diploma in Engineering & Technology in Biotechnology/ Biochemistry / Microbiology / Lifesciences / Chemical Engineering .

Job Requirements: To carry 10-100 L bioreactor operations.

Emoluments: Rs.20,000/- (Rupees Twenty Thousand only) plus 16% HRA per month.
