CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSOCIATE LEVEL-I** initially for a period of **01 Year**, or till the project is over on a temporary contractual basis in the project entitled “**Value-added products using transglycosylating α -glucosidase**” (MLP-0303) at the Department of **Microbiology & Fermentation Technology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: Masters Degree in Natural or Agricultural Sciences/ MVSc or Bachelor’s Degree in Engineering and Technology or Medicine from recognized University or Equivalent in Biotechnology/ Biochemistry / Microbiology / Lifesciences.

Job Requirements: To carry Animal Experiments.

Emoluments: Rs.25,000/- (Rupees Twenty Five Thousand only) plus 16% HRA per month.

1. Candidates should not have exceeded **35** years of age as on **08-10-2022** i.e. the last date of receiving the applications.
