#### **Selection Process:**

- 1. The Selection will be made on the basis of merits of the candidates, based on the following **parametres** viz;
  - a) Academic Performance Index (API) of the candidate (85% Marks)
  - b) Personal Interview test of the candidates (15% Marks)
- 2. The Merit list will be made according to the merit on the basis of marks obtained after totaling marks scored in API & marks obtained in personal interview by a candidate.
- 3. In the recommendation list, merit position of the candidates securing equal marks will be finalized as per their seniority of age and in case of candidates securing equal marks in aggregate and also of the same age will be decided on the basis of percentage of marks obtained in the minimum educational qualification prescribed. The same procedure is to be followed for preparing waiting list of candidates, if there be any.
- 4. The decision of the Recruitment Board shall be considered final in making the merit list of the candidates, based on the criteria of selection.
- 5. The candidates will be selected by the authority from the merit list.
