for Research in Tuberculosis, No.1, Mayor Sathyamoorthy Road, Chetpet, Chennai 600 031 along with self-attested copies of all credentials in support of educational qualifications, age, caste/community and affixing a colour passport size photograph on the application form while reporting for walk-in written test/interview on the date and time mentioned above. Original Certificates of all these credentials should also be carried with for verification.

- 2. Mere fulfilling the essential qualification does not guarantee the selection.
- 3. For reserved category posts, candidates must produce their latest Caste Validity Certificate. OBC candidates must possess a latest valid non-creamy layer certificate. PWD candidates shall produce latest disability certificate issued by a Medical board of Government hospital with not less than 40% disability.
- 4. Age relaxation is admissible in respect of SC/ST/OBC candidates, Retrenched Government Employees, Departmental Candidates (including projects) and Ex-Servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of service rendered in other ICMR research projects will also be admissible for experienced and skilled persons.
- 5. Experience certificate should clearly state the nature of work during the period of employment.
- 6. No-Objection Certificate from the current employer (for Govt./AB/PSU Servants only).
