Burnpur Hospital of SAIL-IISCO Steel Plant invites applications for walk in interview for the Proficiency Trainee (Intern Paramedics) from the persons qualified in the Critical Care Technicians to work in CCU and care for patients on Ventilators for a period of 18 months with consolidated stipend of Rs 17,980 (Rupees Seventeen thousand nine hundred eight only) + skill & knowledge enhancing allowances (approx. Rs. 7,020.00 per month) per month depending upon the actual attendance.

Interested and eligible candidates are requested to send filled in Application form along with copies of educational certificate, caste certificate, work experience (as required) and send the same by Speed Post to **GM (Hosp. Qualification: Critical Care Technician: Degree / Diploma in Critical Care Technology (OR) GNM/ B.Sc (Nursing) with minimum 1 year experience of working in ICU with Ventilator.

Eligible candidates will be called for an interview at Burnpur, Dist.-Paschim Bardhaman, West Bengal; the intimation for which will be sent via email/phone.

PROFICIENCY TRAINING PROGRAMME FOR QUALIFIED CRITICAL CARE TECHNICIAN

Each selected candidate shall be imparted 18 months' training in Critical Care Units during as per their respective qualification or as per the decision of the Company:

Eligibility Conditions:

a) Upper Age limit:

General candidates - 30 years as on 01/12/2022 OBC Candidates - 33 years as on 01/12/2022 ST & SC Candidates - 35 years as on 01/12/2022

PH candidates - 45 for SC/ST, 43 for OBC and 40 for UR

- b) The Medical fitness of the candidate selected as trainee under the instant scheme will be examined by the Medical Officer of Burnpur Hospital, SAIL-IISCO Steel Plant, Burnpur and shall be allowed to join the training only if he/ she has been declared fit for the programme.
- c) The candidate selected as Trainees shall be required to produce all the testimonials and certificates of relevant qualification (matriculation onwards) as detailed below:
- d) Candidates are also required to submit the certificates pertaining to SSLC and HSC / previous examination passed during the time of selection.

Selection Procedure:

The trainees to be inducted shall be based on the performance of the candidates in the interview subject to their fulfilling the advertised eligibility criteria.

Training Hours:

The training shall be imparted for 8 hours in a day and 48 hours in a week.

Stipend& Allowance:

Stipend: Rs.17,980.00 per month for the trainees engaged under this programme. Pro-rata deduction of stipend shall be applicable for the days of absence. In addition to the stipend the trainees shall also be eligible for Knowledge and Skill enhancement allowance as below:

The maximum amount payable to the Nurse trainees will be Rs 17,980.00 (stipend) + Rs 7,020.00 (Rs.260.00 x maximum 27 days as allowance) = Rs.25,000.00. Payment shall be made only through Bank. The trainees shall not be entitled to any other payment other than what has been mentioned above.

Facilities admissible during the period of training:

- a) The trainees, shall be entitled to medical facilities (without referral) for self only at company's hospital.
- b) Accommodation facility for self only may be considered as per availability on payment basis.
- c) On successful completion of the training, a Certificate of Proficiency shall be issued to the trainees by the SAIL-IISCO Steel Plant Hospital.

Leave facilities during the period of training:

The trainees, shall be entitled to 7 (seven) days' Casual Leave and Closed Holidays (or Compensatory off thereof) on National Holidays.

Conduct and Discipline during the period of training:

- a) The Proficiency Training Programme (Intern Paramedic) is purely temporary for a period of 18 months. The training can be terminated without notice if the Conduct / Performance are not found to be satisfactory.
- b) The selected trainee shall execute an Affidavit on a Judicial Stamp Paper of Rs.10/- (as per the format annexure I) at the time of joining and to serve the IISCO Steel Plant Hospital strictly as a vocational trainee and will not claim for employment in the IISCO Steel Plant Hospital, Burnpur or in any Plant / Unit of SAIL on this ground, nor will the trainee raise any dispute in this respect. The trainee shall also declare that he/she will complete the training period.
- c) The trainee shall follow the norms of Safety, Discipline, Conduct and Professional Ethics and also carry out the lawful orders of the Medical Administration issued from time to time. The trainee shall obey all such orders and directions as received from the superiors.
