PUBLIC NOTICE

RECRUITMENT TO 41 POSTS OF DEPUTY DISTRICT ATTORNEY IN THE DEPARTMENT OF HOME AFFAIRS AND JUSTICE, GOVERNMENT OF PUNJAB.

1. It is for the information of the candidates who had appeared in the written competitive examination for recruitment to these posts held on 18/12/2022 (Sunday), that as per answer key uploaded on the website dated 18/12/2022, the candidates mentioned in the list attached as Annexure- A have been provisionally shortlisted for interview. This Shortlisting is subject to final outcome of the CWP Nos. 8237, 8110, 8100, 8280, 8616, 10771, 24009, 9184, 27977, 27172 of 2022.
2. The candidates mentioned in Annexure- A are in the order of respective roll numbers and not as per written competitive exam merit to keep the written exam score concealed from the interview panel.
3. As per the provisions of paragraph-8.6 of "General Information to the Candidates", the candidates of Annexure- A are directed to submit their online application form along with copy of all the eligibility documents **in person only** from 31/01/2023 to 01/02/2023 (10 A.M. to 4 P.M) in the office of PPSC for scrutiny of documents, as per Date and Time Slot attached failing which their candidature for the ibid posts may be cancelled. To avoid any rush and chaos Candidates are advised to strictly follow the Date and Time Slot.
4. The Candidates MUST bring the following Self Attested documents along with signed copy of the application form:-
 - (a) Proof of Date of Birth: Certificate of Matriculation / Higher Secondary.
 - (b) Proof of having passed Punjabi Language up to matric or its equivalent Standard.
 - (c) Degree and DMC Certificates as mentioned in Essential Qualification of General Information.
 - (d) Experience certificate with accurate dates and reference no. issued by the Competent Authority.
 - (e) Caste Reserved Category Certificate issued by the Competent Authority (If applicable).

- (f) Latest Punjab Residence certificate (all Reserve Categories including female candidates who have applied in General Category) issued by competent authority.
- (g) If ESM/LDESM(in original), Certificates/Documents mentioning the following:
 - i) Date of Enrolment.
 - ii) Date of Release/Discharge.
 - iii) Reasons of Release/Discharge.
- (h) Original Documents to claim exemption from Punjabi Language pass up to matric or its equivalent Standard (If applicable).
 - (i) Certificate as proof of age relaxation claim (If applicable).
 - (j) Certificate as proof of fee concession (If applicable).
 - (k) Proof of being Govt. Employee (If applicable).
 - (l) Enrolment Certificate as Advocate.
 - (m) Any other certificate(If applicable).
 - (n) Copy of Bank Challan form.

5. Candidates are also required to bring Original Documents at the time of submission of Copies of documents for Scrutiny.

6 The application forms and requisite documents of provisionally shortlisted candidates shall be scrutinized by the Commission. During the scrutiny of application forms, if any provisionally shortlisted candidate is found ineligible, then his/her candidature shall be cancelled by the Commission.

7. The number of candidates provisionally shortlisted in each category is subject to their clearing the passing criteria(as mentioned at paragraph no.6.8. of General Information) of 40% marks (35% for candidates belonging to Scheduled castes of Punjab and Backward Classes of Punjab). The number of such provisionally shortlisted candidates may be more than the number of posts in some categories to cater to any cancellation of candidatures arising out of the scrutiny of documents. It is reiterated that the candidates have been provisionally shortlisted subject to final outcome of the CWP Nos. 8237, 8110, 8100, 8280, 8616, 10771, 24009,9184, 27977, 27172 of 2022.

8. While every care has been taken in preparing and uploading the list of short-listed candidates for scrutiny of documents, possibility of inadvertent/technical errors cannot be ruled out. The Commission reserves the right to rectify the same later on.
