#### AGE LIMIT:

The upper age limit for superannuated candidate on the date of advertisement shall be 65 years whereas for other candidates, it shall be 40 years.

# Educational Qualification/eligibility for the appointment of "Guest Lecturer" (for the candidates other than superannuated candidates):

- 1) A Master's degree with minimum 7.00 CGPA/OGPA or 70% marks for the candidates graduated from Agricultural / Veterinary University and minimum 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) for the candidates graduated from other than Agricultural / Veterinary University in the concerned subject from an Indian University, or an equivalent degree from an accredited foreign university. However, relaxation in the minimum CGPA/OGPA or marks shall be permissible as per rule.
- 2) The candidate must possess graduation degree from concerned faculty.
- 3) Ph.D. in the concerned subject/discipline

**Note:** Ph.D. degree is mandatory for appointment as "Guest Lecturer". However if the candidate with Ph.D. Degree in particular subject is not available, then the candidate with National Eligibility Test (NET) conducted by the UGC /CSIR/ICAR/ASRB, or a similar test accredited by the UGC, like SLET/SET conducted by Maharashtra shall be considered.

#### **TERMS, CONDITIONS & GENERAL INSTRUCTIONS**

The interested candidates shall download the prescribed application form from University website <u>www.mafsu.in</u> and shall submit the same duly completed in all respect to the Registrar of the University **on or before 10/03/2023 up to 23.59 hrs by email registrar@mafsu.in or by post.** 

- 1. The superannuated candidates shall submit an application on plain paper addressed to the Registrar, MAFSU, Nagpur in their own handwriting stating the subject of specialization, length of service, name of organization, teaching experience, date of birth, proof of age, the date of superannuation and the name of subject for which the application is made.
- 2. The other candidates shall submit the application in the prescribed format which can be downloaded from the University website <u>www.mafsu.in</u>
- 3. Incomplete applications and the applications received after the last date as prescribed above shall not be considered and no correspondence in this respect shall be entertained.
- 4. The application duly signed by the candidate shall only be entertained.
- 5. The candidates are advised to fill in the prescribed application form completely in legible handwriting or in typewritten form. Incomplete and illegible application forms and those that are not in the prescribed format shall not be considered.
- 6. The application form shall be rejected and no communication in this regard shall be made in case; a) the candidate does not possess essential academic qualifications and/ or experience b) the candidate exceeds the maximum age limit prescribed for the post c) self attested copies of essential documents and certificates such as qualifications, experience, age etc. are not enclosed and uploaded on given email.
- 7. The candidate must enclose self attested photocopies of all the publications, awards, certificates etc. along with application form and shall be sent on the email **registrar@mafsu.in**
- 8. The appointment as "Guest Lecturer" is purely Temporary and for not more than eleven months or till the posts are filled in on regular basis whichever is earlier.
- 9. The candidate appointed as "Guest Lecturer" cannot claim for the permanency in the University services.
- 10. The candidate appointed as "Guest Lecturer" shall have to perform the duties of Assistant Professor enumerated in the MAFSU Statute 2002.
- 11. The honorarium of Rs. 1500/- per lecture (hour) maximum upto Rs. 50,000/- per month shall be paid to the candidate selected as "Guest Lecturer".
- 12. The candidate selected as "Guest Lecturer" shall have to furnish a bond/ undertaking on stamp paper of Rs. 100/- while joining to the Registrar, MAFSU, Nagpur stating that he/she shall not claim the permanency in the University service in future and he/she shall work in only one constituent college at a time.
- 13. If response from superannuated candidate is inadequate, then the other candidates fulfilling educational qualification and other criteria will be called for interview. Mere possession of eligibility doesn't impart any right to a candidate for being called for interview.
- 14. If disproportionally large numbers of applications are received, University may adopt a suitable criteria to short list the candidates.
- 15. The University shall not be responsible for any delay or any loss in transit of application. Applications received after the last date of submission shall be rejected and no correspondence in this regard shall be entertained.
- 16. The University reserves the right to appoint any selected candidate at any of its constituent colleges, even though the candidate has applied for a specific college.
- 17. The candidate shall have to appear for interview, if called for, at his/her own cost.

- 18. If at any time after appointment, it is found that the candidate has submitted false information, document, his/her appointment shall be terminated without prior intimation/ notice.
- 19. Candidate must furnish the detailed information regarding suspension, removal from previous service or any criminal prosecution against him/her or nature of punishment ordered thereof, if any.
- 20. If the departmental enquiry is being conducted or pending/proposed against the superannuated candidate or he/she is punished according to the enquiry, such candidate shall not be eligible for appointment as "Guest Lecturer".
- 21. The candidate should be physically and mentally fit for appointment as "Guest Lecturer" and need to submit a certificate in this regard from the Medical Officer.
- 22. The candidate should attach a separate sheet indicating the list of documents/ certificates enclosed along with the application form in a chronological order.
- 23. If the space provided for any item is insufficient, candidate may attach self attested separate sheets for the purpose.
- 24. Documents/Certificates issued by the competent authority shall only be considered.
- 25. A response to every item in the application form must be given, if the information is Nil or not applicable, the same may be indicated accordingly.
- 26. Fraud information shall disqualify the candidature and shall be liable for punishment.
